



## Processing of member information in the Bridge-55 and the Finnish Bridge Association

Bridge 55 ry (B-55) is a member of the Finnish Bridge Association (SBL). SBL is the central organization of the bridge in Finland. B-55 collects personal information from its members and handles them together with SBL.

B-55 collects from joining member the name, address, gender and from junior member birth year. SBL creates a national member number for the new member.

B-55 is legally obliged to keep a member register, which should include the member's name and domicile.

The B-55 keeps its membership register at Avoine's Membership registry program (Yhdistysavain). B-55 transfers the member's information to the service provider's registry program.

The club membership fee includes SBL's share. SBL's subscription includes the Bridge-magazine subscription. The subscription to Bridge-magazine is an agreement for which the SBL addresses the name and address.

Club membership is a prerequisite for participation in SBL competitions. The SBL uses a register of members of the club to ensure the right of participation; this is a legitimate interest in organizing SBL's competitive activities.

SBL will hand over the name and address details of Bridge-magazine's mail order company. SBL has an agreement with the mail-order company; the postal company processes personal data for SBL and is not entitled to use the information for its own purposes.

The B-55 collects the email address and mobile phone number with the consent of the member. Information is used to communicate between a member and a club. Information is not given to anyone or used to anything else. If the Member agrees to the collection of the data, the consent of the consent must be a concrete one, eg a signed form. A member has the right to withdraw consent at any time.

The person has the following rights to handle personal data:

- 1) A person has the right to ask for information about himself. These must be submitted within 30 days upon request.
- 2) A person has the right to request the updating of incorrect information.
- 3) A person has the right to withdraw consent to the processing of the e-mail address; then the information must be deleted.
- 4) A person has the right to request the removal of his or her data if the person is not a member of the club.
- 5) A person has the right to appeal to the supervisory authority if he or she feels that his or her rights have been violated.
